### **FURTHER CLARIFICATION ANNOUNCEMENT**

The Directors refer to the clarification announcement published by the Company on 15 September 2003. The Directors wish further to clarify that the content of the Articles is accurate, that the source of the Information was from the Company, and that an agreement entered into by a subsidiary of the Company on 2nd September, 2003 is in accordance with the "Reasons for the Placing and Use of Proceeds" stated in the prospectus of the Company dated 13 February, 2003.

The directors (the "Directors") of KanHan Technologies Group Limited (the "Company") refer to the clarification announcement published by the Company on 15th September, 2003 and certain press articles (the "Articles") appearing in the Sing Tao Daily and the Hong Kong Economic Journal newspapers on 15 and 16 September, 2003 regarding the Company's plan to engage in business related to soccer information database services. An agreement (the "Agreement") was signed between Kanhan Technologies Limited ( a subsidiary of the Company ) (the "Subsidiary") and Goal Evening Post Limited ("Goal") Goal owns a newspaper, namely Goal Evening Post, which publishes news and features on international soccer and possesses a soccer information database (the "Information"). The Information as provided by Goal is expected to be published in a Web page to be designed and hosted by the Company which is now under design. Details of the Web page are not available at present The Directors expect that the Company will utilise its HanVoice and HanWeb and HanPhone services to enable the users to access to the Web through fixed line telephone, mobile phones and mobile phone SMS text messaging to obtain the information. Such information is to assist the users to access updated soccer information. HanWeb is the Company's proprietary software that translates traditional Chinese into Simplified Chinese and vice versa. HanVoice is the Company's proprietary software that translates Chinese text into speech. The promotion of these products forms part of the Company's principal business. The distribution of fee income between the Company and Goal is yet to be determined.

The Directors further clarify that the Company is not engaged in football betting and has no change in the principal business.

The Directors consider that the Agreement conforms with the Company's business objective and Use of Proceeds as set on page 108 and page 112 respectively of the Prospectus under "Statement of Objectives". Made by the order of the Board, the Directors collectively and individually accept responsibility for the accuracy of this announcement.
