CHANGE OF COMPANY NAME

The Board is pleased to announce that the Certificate of Incorporation on Change of Name was issued by the Registrar of Companies in the Cayman Islands on 13 February 2008 certifying that the change of name of the Company in English from “KANHAN TECHNOLOGIES GROUP LIMITED” to “Shen Nong China (Group) Limited” and in Chinese from “看漢科技集團有限公司” to “神農中國(集團)有限公司”. The change of the Company’s name took effect on 16 January 2008. The Certificate of Registration of Change of Corporate Name of Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 2 April 2008 confirming the registration of the new English name “Shen Nong China (Group) Limited” and the new Chinese name “神農中國(集團)有限公司” in Hong Kong under Part XI of Companies Ordinance.

STOCK SHORT NAME

The shares of the Company will be traded on the Stock Exchange under the new English stock short name of “SHEN NONG CHINA” and “神農中國” in Chinese, instead of “KANHAN TECH” and “看漢科技”, with effect from 14 April 2008.

EXCHANGE OF SHARE CERTIFICATES

The existing share certificates of the Company shall continue to be evidence of title and valid for trading, settlement, delivery and registration purposes. There will not be any arrangement for exchange of the existing share certificates.

The principal place of business of the Company will be changed to Unit 1601, Ruttonjee House, Ruttonjee Centre, 11 Duddell Street, Central, Hong Kong with effect from 14 April 2008.

CHANGE OF COMPANY NAME

Reference is made to the previous announcement of the Company dated 2 November 2007 (the “Announcement”) and the circular of the Company dated 24 December 2007 (the “Circular”) regarding the proposed change of company name.
