The board of directors of Sino Golf Holdings Limited proposes to implement the capital reduction involving the reduction of the paid-up capital of each of the issued shares by cancelling the paid-up capital to the extent of HK\$0.09 per issued share so that the nominal value of each issued share will be reduced from HK\$0.10 to HK\$0.01. Immediately following the capital reduction becoming effective, each authorised but unissued share will also be sub-divided into ten (10) new shares with a nominal value of HK\$0.01 each. Subject to the capital reorganisation becoming effective, the board proposes a bonus issue of new shares on the basis of four (4) bonus shares for every one (1) new share held by the qualifying shareholders. The board proposes that subject to and upon the capital reorganisation and the bonus issue becoming effective, the board lot size be changed from 2,000 shares to 20,000 new shares. The special general meeting is proposed to be convened and held on 6 January 2016 for the shareholders to consider and, if thought fit, to approve the capital reorganisation and the bonus issue.
