| <p>1. <u>On 8 July 2016, Sino Golf Holdings Limited (the "Company") entered into a subscription agreement pursuant to which, the Company has conditionally agreed to allot and issue to the subscriber and the subscriber has conditionally agreed to subscribe for: (i) an aggregate of 2,861,000,000 subscription shares at the subscription price of HK\$0.114 per subscription share; and (ii) convertible bonds in the aggregate principal amount of HK\$74,100,000, which entitle the subscriber to subscribe for 650,000,000 conversion shares at the initial conversion price of HK\$0.114 per conversion share. The special general meeting is proposed to be convened and held on 20 October 2016 for the shareholders to consider and, if thought fit, approve the subscription agreement and the transactions, including (among other matters) the allotment and issue of the subscription shares, the convertible bonds and the conversion shares falling to be allotted and issued upon the exercise of the conversion rights attaching to the convertible bonds, and the whitewash waiver and the election of the subscriber's nominees as directors, effective upon subscription completion (or any adjournment thereof).
