## **VOLUNTARY ANNOUNCEMENT SALES VOLUME IN SEPTEMBER 2013**

The board of directors of the Company (the "**Board**") is pleased to announce that the total sales volume of the Group for the month of September 2013 was 43,027 units, similar to the level achieved in the same period last year, but up approximately 22% from August 2013. The total sales volume in the first nine months of 2013 was 375,810 units, up 16% from the same period last year and achieving 67% of the full year sales volume target of 560,000 units in 2013. The Group's exports volume was 8,488 units in September 2013, down around 27% from the same period last year. During the month of September 2013, the Group's total sales volume in China market was 34,539 units, an increase of around 10% from the same period last year.

During the month of September 2013, the sales volume of the Group's best selling model "Emgrand EC7" was 15,072 units, a slight increase of about 1% over the same period last year and representing the third highest monthly sales volume level this year so far. The aggregate sales volume of "GX7" and "SX7", the Group's Sport Utility Vehicles (SUVs), reached its record high at 5,715 units in September 2013, an increase of about 26% over the same period last year. Also, the sales volume of "GC7" was 4,607 units in September 2013, again a record high for the model, and a significant increase of 335% over the same period last year.
