# Pursuant to the Company's announcement dated 29 March 2012, the board of directors of Kiu Hung Energy Holdings Limited (the "Company", together with its subsidiaries, (the "Group")) resolved to grant an aggregate of 228,000,000 share options (the "Share Options") to subscribe for ordinary shares of HK\$0.02 each of the Company (the "Shares") to the Company's executive directors and independent non-executive directors, and employees of the Group under the existing share option scheme of the Company adopted on 28 May 2002. The exercise price of (i) 114,000,000 Share Options is HK\$0.0644 per Share; and (ii) the remaining 114,000,000 Share Options is HK\$0.0773 per Share. Validity period of the Share Options is 3 years from 29 March 2012 and exercisable upon acceptance of the grant. As of the date of submission of this monthly return, the acceptance procedure of the share options has not yet been completed.
