On 7 November 2013, the Company announced that the Company proposed a capital reduction whereby the par value of each of the issued existing shares from HK\$0.1 be reduced to HK\$0.01 per share by cancelling paid-up capital of HK\$0.09 per share, so as to form ordinary shares with par value of HK\$0.01 each; and immediately following the capital reduction, each of the authorized but unissued ordinary shares with par value of HK\$0.1 each be subdivided into ten (10) unissued ordinary shares with par value of HK\$0.01 each.

The above proposed capital reorganization was approved by the shareholders at the EGM held on 11 December 2013 and the capital reorganization become effective after 10:00 pm on 25 March 2014.
