1. INTRODUCTION

The purpose of this circular is to provide Shareholders with information in respect of the resolutions to be proposed at the 2010 AGM for (i) the granting of the Issuance Mandate to the Directors; (ii) the granting of the Buyback Mandate to the Directors; (iii) the extension of the Issuance Mandate by adding to it the nominal amount of issued Shares repurchased by the Company under the Buyback Mandate; and (iv) the re-election of the retiring Directors.

2. PROPOSED GRANTING OF THE ISSUANCE AND BUYBACK MANDATES

At the annual general meeting of the Company held on 28 August 2009, general mandates were granted to the Directors to exercise the powers of the Company to issue new Shares not exceeding 46,873,515 Shares and to repurchase Shares not exceeding 23,436,757 Shares respectively. During the period from the annual general meeting held on 28 August 2009 to the Latest Practicable Date, the said general mandate to repurchase Shares has not been used whereas the general mandate to issue new Shares has been utilized substantially by the Company through the issue in April 2010 of convertible notes which carry the rights to convert into a maximum of 46,860,356 Shares (“Conversion Shares”) at an initial conversion price of HK\$0.3201 (subject to adjustments). The details of the issue were set out in the announcement of the Company dated 8 April 2010. Up to the Latest Practicable Date, 6,248,047 Conversion Shares have been issued.

The said general mandates to issue and repurchase Shares granted on 28 August 2009, to the extent not utilized by the date of the 2010 AGM, will lapse at the conclusion of the 2010 AGM. Ordinary resolutions will be proposed at the 2010 AGM to approve the granting of new general mandates to the Directors:

- (a) to allot, issue or deal with new Shares of an aggregate nominal amount not exceeding 20% of the total nominal amount of the issued ordinary share capital of the Company as at the date of passing of such resolution (i.e. an aggregate nominal amount of Shares not exceeding HK\$5,365,392.4 (equivalent to 53,653,924 Shares) on the basis that the issued ordinary share capital of the Company remains unchanged as at the date of the 2010 AGM) (the “Issuance Mandate”);
- (b) to purchase Shares on the Stock Exchange of an aggregate nominal amount not exceeding 10% of the total nominal amount of the issued ordinary share capital of the Company as at the date of passing of such resolution (i.e. an aggregate nominal amount of Shares not exceeding HK\$2,682,696.2 (equivalent to 26,826,962 Shares) on the basis that the issued ordinary share capital of the Company remains unchanged as at the date of the 2010 AGM) (the “Buyback Mandate”); and
- (c) to extend the Issuance Mandate by an amount representing the aggregate nominal amount of issued Shares repurchased by the Company pursuant to and in accordance with the Buyback Mandate.

The Issuance Mandate and the Buyback Mandate will continue in force until the conclusion of the next annual general meeting of the Company held after the 2010 AGM or any earlier date as referred to in the proposed ordinary resolutions contained in items 8 and 9 of the notice of the 2010 AGM as set out on pages 12 to 15 of this circular. With reference to the Issuance Mandate and the Buyback Mandate, the Directors wish to state that they have no immediate plan to repurchase any Shares or issue any new Shares pursuant thereto.

In accordance with the requirements of the Listing Rules, the Company is required to send to Shareholders an explanatory statement containing all the information reasonably necessary to enable them to make an informed decision on whether to vote for or against the granting of the Buyback Mandate. The explanatory statement as required by the Listing Rules in connection with the Buyback Mandate is set out in Appendix I to this circular.

3. PROPOSED RE-ELECTION OF THE RETIRING DIRECTORS

Pursuant to Bye-law 87 of the Current Bye-laws, at each annual general meeting of the Company, one-third of the Directors for the time being (or, if their number is not a multiple of three, the number nearest but not less than one-third) shall retire from office by rotation provided that every Director (including Director(s) appointed for a specific term) shall be subject to retirement by rotation at least once every three years. The Directors to retire by rotation shall include (so far as necessary to ascertain the number of Directors to retire by rotation) any Director who wishes to retire and not to offer himself for re-election. Any further Directors so to retire shall be those of the other Directors subject to retirement by rotation who have been longest in office since their last re-election or appointment. As between persons who became or were last re-elected Directors on the same day, the person(s) to retire shall (unless they otherwise agree among themselves) be determined by lot. A retiring Director shall be eligible for re-election by the Shareholders at the relevant annual general meeting.

According to the above Bye-law 87, Dr. Li Zhong Yuan and Mr. Zhou Bao Yi shall retire by rotation at the 2010 AGM. Both of the above two retiring Directors, being eligible, will offer themselves for re-election at the 2010 AGM. Pursuant to Rule 13.74 of the Listing Rules, a listed issuer shall disclose the details required under Rule 13.51(2) of the Listing Rules of any director proposed to be re-elected or proposed new director in the notice or accompanying circular to its shareholders of the relevant general meeting, if such re-election or appointment is subject to shareholders' approval at that relevant general meeting. The requisite details of Dr. Li Zhong Yuan and Mr. Zhou Bao Yi are set out in Appendix II to this circular.

4. 2010 AGM AND PROXY ARRANGEMENT

The notice of the 2010 AGM is set out on pages 12 to 15 of this circular. At the 2010 AGM, resolutions will be proposed to approve, inter alia, the granting of the Issuance Mandate and the Buyback Mandate, the extension of the Issuance Mandate by the addition thereto of the nominal amount of Shares repurchased by the Company pursuant to the Buyback Mandate and the re-election of the retiring Directors.

A form of proxy for use at the 2010 AGM is enclosed with this circular and such form of proxy is also published on the websites of the Stock Exchange (www.hkexnews.hk) and the Company (www.chinahealthcareltd.com). Whether or not you are able to attend the 2010 AGM, please complete and sign the form of proxy in accordance with the instructions printed thereon and return it, together with the power of attorney or other authority (if any) under which it is signed or a certified copy of that power of attorney or authority, to the Branch Share Registrar of the Company in Hong Kong, Tricor Tengis Limited, at 26/F, Tesbury Centre, 28 Queen's Road East, Wanchai, Hong Kong, as soon as possible but in any event not less than 48 hours before the time appointed for holding the 2010 AGM or any adjournment thereof. Completion and delivery of the form of proxy will not preclude you from attending and voting at the 2010 AGM or any adjournment thereof if you so wish and in such event, the proxy form shall be deemed to be revoked.

5. VOTING BY WAY OF POLL

Pursuant to the Listing Rules, any vote of shareholders at a general meeting must be taken by poll. Accordingly, all the proposed resolutions will be put to vote by way of poll at the 2010 AGM. An announcement on the poll results of the 2010 AGM will be made by the Company after the 2010 AGM in accordance with the requirements under Rule 13.39(5) of the Listing Rules.

6. RECOMMENDATION

The Directors consider that the granting of the Buyback Mandate, the granting and extension of the Issuance Mandate and the re-election of the retiring Directors are in the interests of the Company and the Shareholders as a whole. Accordingly, the Directors recommend the Shareholders to vote in favour of the relevant resolutions to be proposed at the 2010 AGM.

7. GENERAL INFORMATION

Your attention is drawn to the additional information set out in Appendix I (Explanatory Statement on the Buyback Mandate) and Appendix II (Details of the retiring Directors proposed to be re-elected at the 2010 AGM) to this circular.

The following is an explanatory statement required by the Listing Rules to be sent to the Shareholders to enable them to make an informed decision on whether to vote for or against the ordinary resolution to be proposed at the 2010 AGM in relation to the granting of the Buyback Mandate.

1. REASONS FOR BUYBACK OF SHARES

The Directors believe that the granting of the Buyback Mandate is in the interests of the Company and the Shareholders. Repurchases of Shares may, depending on the market conditions and funding arrangements at the time, lead to an enhancement of the net asset value per Share and/or earnings per Share. The Directors are seeking the granting of the Buyback Mandate to give the Company the flexibility to do so if and when appropriate. The number of Shares to be repurchased on any occasion and the price and other terms upon which the same are repurchased will be decided by the Directors at the relevant time, having regard to the circumstances then pertaining.

2. SHARE CAPITAL

As at the Latest Practicable Date, the issued ordinary share capital of the Company comprised 268,269,624 Shares.

Subject to the passing of the ordinary resolution set out in item 9 of the notice of the 2010 AGM in respect of the granting of the Buyback Mandate and on the basis that the issued ordinary share capital of the Company remains unchanged on the date of the 2010 AGM, i.e. being 268,269,624 Shares, the Directors would be authorized under the Buyback Mandate to repurchase, during the period in which the Buyback Mandate remains in force, an aggregate nominal amount of Shares up to HK\$2,682,696.2 (equivalent to 26,826,962 Shares), representing 10% of the aggregate nominal amount of the issued ordinary Shares as at the date of the 2010 AGM.

3. FUNDING OF REPURCHASES

In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with its Memorandum of Association and Bye-laws, the laws of Bermuda and/or any other applicable laws, as the case may be.

The Company is empowered by its Memorandum of Association and the Current Bye-laws to repurchase Shares. The laws of Bermuda provide that the amount of capital paid in connection with a share repurchase by a company may only be paid out of the capital paid up on the relevant shares, or funds of the company which would otherwise be available for dividend or distribution or out of the proceeds of a fresh issue of shares made for such purpose. The amount of premium payable on a repurchase may only be paid out of the funds of the company which would otherwise be available for dividend or distribution or out of the share premium account of the company.

4. IMPACT OF REPURCHASES

There might be a material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in the audited accounts contained in the annual report of the Company for the year ended 31 March 2010) in the event that the Buyback Mandate was to be carried out in full at any time during the proposed repurchase period. However, the Directors do not intend to exercise the Buyback Mandate to such an extent as would, in the circumstances, have a material adverse effect on the working capital or the gearing levels of the Company which in the opinion of the Directors are from time to time appropriate for the Company.

5. TAKEOVERS CODE

If, on the exercise of the power to repurchase Shares pursuant to the Buyback Mandate, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of the Takeovers Code. Accordingly, a Shareholder, or a group of Shareholders acting in concert, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code for all the Shares not already owned by such Shareholder or group of Shareholders.

As far as the Directors are aware, as at the Latest Practicable Date, there was no Shareholder holding 10% or more in the issued Shares. The Directors are not aware of any consequences which will arise under the Takeovers Code as a result of any repurchase to be made under the Buyback Mandate.

6. GENERAL

None of the Directors or, to the best of their knowledge having made all reasonable enquiries, any of their respective associates (as defined in the Listing Rules) have any present intention to sell any Share to the Company in the event that the granting of the Buyback Mandate is approved by the Shareholders.

The Company has not been notified by any connected persons (as defined in the Listing Rules) of the Company that they have a present intention to sell any Share to the Company, or that they have undertaken not to sell any Share held by them to the Company in the event that the granting of the Buyback Mandate is approved by the Shareholders.

The Directors have undertaken to the Stock Exchange to exercise the power of the Company to make repurchases of Shares pursuant to the Buyback Mandate in accordance with the Listing Rules and the applicable laws of Bermuda.

8. REPURCHASES OF SHARES MADE BY THE COMPANY

No repurchases of Shares have been made by the Company during the previous six months (whether on the Stock Exchange or otherwise).

Pursuant to the Listing Rules, the details of the Directors, who will retire and offer themselves for re-election at the 2010 AGM according to the Current Bye-laws, are provided below.

(1) **DR. LI ZHONG YUAN**

Dr. Li Zhong Yuan, aged 48, is an executive Director and the Chairman of the Company and is responsible for the overall strategic planning of the Group. He is also a director of certain subsidiaries of the Company. Dr. Li received his PhD. in Mathematics from the University of Michigan at Ann Arbor, the USA and subsequently worked as an Assistant Professor of Mathematics at the Massachusetts Institute of Technology, the USA (“MIT”), where he was consecutively awarded research grants from the National Science Foundation. After MIT, he held senior positions with a number of major international investment banks, including Bankers Trust Company, Salomon Brothers and IBJ Asia Limited and has extensive experience in capital raising and risk management. In late 1996, he was in charge of building up capital markets and derivative businesses in multi-asset classes in Northern Asia and was a director of Rabobank International before setting up a financial and technology investment firm. Dr. Li has not held other directorships in the last three years in public companies the securities of which are listed on any securities market in Hong Kong or overseas.

Dr. Li has a service contract with the Company for a term of two years commencing from 1 September 2009. He is subject to retirement by rotation and re-election at the annual general meeting of the Company in accordance with the Current Bye-laws. The provisions of the Current Bye-laws in respect of Directors’ retirement by rotation and re-election have been set out in paragraph 3 of the Letter from the Board in this circular.

The salary and other benefits of Dr. Li amount to HK\$2,052,000 per annum, which has been determined by the Board by reference to his performance, experience, time commitment and responsibilities as well as the prevailing market conditions.

As far as the Directors are aware, Dr. Li does not have any relationships with any other Directors, senior management, substantial Shareholders (as defined in the Listing Rules), or controlling Shareholders (as defined in the Listing Rules) of the Company. Besides, as at the Latest Practicable Date, Dr. Li had the following interests in the issued/underlying Shares pursuant to Part XV of the SFO:

- (i) He owned 13,296,000 issued Shares personally, representing approximately 4.96% of the issued ordinary share capital of the Company.
- (ii) He was deemed to be interested in 11,147,000 issued Shares, representing approximately 4.16% of the issued ordinary share capital of the Company, which were held by Pacific Annex Capital Limited, a company wholly owned by Dr. Li.
- (iii) He held 6,244,000 share options granted by the Company, which entitled him to subscribe for 6,244,000 Shares, representing approximately 2.33% of the issued ordinary share capital of the Company.

Save as disclosed above, Dr. Li was not interested or deemed to be interested in any Shares or underlying Shares of the Company pursuant to Part XV of the SFO.

As far as the Directors are aware, there is no information of Dr. Li to be disclosed pursuant to any of the requirements under paragraphs 13.51(2)(h) to 13.51(2)(v) of the Listing Rules; and there are no other matters concerning Dr. Li that need to be brought to the attention of the Shareholders.

(2) MR. ZHOU BAO YI

Mr. Zhou Bao Yi, aged 48, was appointed as an Independent Non-executive Director on 1 December 2006 and has been re-designated as an Executive Director with effect from 6 July 2007. He is the president of Vision Holding Technology Co. Ltd.. Mr. Zhou received his Master degree in economics from People's University, PRC and is a certified Senior Accountant in the PRC. Mr. Zhou was the Chief Accountant, president and chairman in Northeastern Electric Transmission And Transformation Equipment Group Ltd.. Mr. Zhou has not held other directorships in the last three years in public companies the securities of which are listed on any securities market in Hong Kong or overseas.

Currently, there is no service contract entered into between Mr. Zhou and the Company and he has not been appointed for any fixed term. However, he is subject to retirement by rotation and re-election at the annual general meeting of the Company in accordance with the Current Bye-laws. The provisions of the Current Bye-laws in respect of Directors' retirement by rotation and re-election have been set out in paragraph 3 of the Letter from the Board in this circular.

The salary and other benefits of Mr. Zhou amount to HK\$501,000 per annum, which has been determined by the Board by reference to his performance, time commitment, responsibilities and the prevailing market conditions.

As far as the Directors are aware, (1) Mr. Zhou does not have any relationships with any other Directors, senior management, substantial Shareholders (as defined in the Listing Rules), or controlling Shareholders (as defined in the Listing Rules) of the Company; and (2) as at the Latest Practicable Date, Mr. Zhou held 1,002,000 share options granted by the Company which entitled him to subscribe for 1,002,000 Shares, representing approximately 0.37% of the issued ordinary share capital of the Company. Save as disclosed above, Mr. Zhou was not interested or deemed to be interested in any Shares or underlying Shares of the Company pursuant to Part XV of the SFO.

As far as the Directors are aware, there is no information of Mr. Zhou to be disclosed pursuant to any of the requirements under paragraphs 13.51(2)(h) to 13.51(2)(v) of the Listing Rules; and there are no other matters concerning Mr. Zhou that need to be brought to the attention of the Shareholders.
