ANNOUNCEMENT

Jinhui Holdings Company Limited (the “Company”) has been informed by Jinhui Shipping and Transportation Limited (“Jinhui Shipping”), an approximately 50.9 per cent. owned subsidiary of the Company whose shares are listed on the Oslo Stock Exchange, that Jinhui Shipping had repurchased shares of Jinhui Shipping (“JST Shares”) on 24 August 2004 and the details of the repurchase are as follows:

The above repurchased JST Shares were repurchased on the Oslo Stock Exchange and will be cancelled accordingly. Following the above repurchase and upon cancellation of the repurchased JST Shares, Jinhui Shipping will have 88,697,341 shares outstanding and will become an approximately 56.48 per cent. owned subsidiary of the Company.
