ANNOUNCEMENT

The above repurchased JST Shares were repurchased on the Oslo Stock Exchange and will be cancelled accordingly. Following the above repurchase and upon cancellation of the repurchased JST Shares, Jinhui Shipping will have 88,586,341 shares outstanding and will become an approximately 56.55 per cent. owned subsidiary of the Company.
