## JIN - APPOINTMENT OF AUDITORS

The board of directors (the "Board") of Jinhui Shipping and Transportation Limited (the "Company") announces that Grant Thornton has been appointed by the Board as auditors of the Company with effect from 28 December 2007. Grant Thornton will hold office until the conclusion of the next annual general meeting of the Company.

During the year, the Company's auditors, Moores Rowland Mazars announced that with effect from 1 June 2007 it would change its name to Moores Rowland and would subsequently combine its business with Grant Thornton. In anticipation of the reorganization, at the annual general meeting of the Company held on 3 May 2007, the shareholders of the Company authorized the Board to appoint Grant Thornton as auditors of the Company upon completion of the reorganization. Pursuant to this authority, the Board and the Audit Committee of the Company have decided to appoint Grant Thornton as auditors of the Company.
