### RESULTS OF SPECIAL GENERAL MEETING

The Directors are pleased to announce that the resolution to approve the disposal of the entire interest in BAA Jet Management Limited (the "Transaction") was duly passed by the Shareholders at the SGM held on January 9, 2008 by way of poll.

Reference is made to the announcement of the Company dated December 5, 2007 and the circular of the Company dated December 24, 2007 (the "Circular") in relation to the Transaction. Terms used in this announcement shall have the same meanings as those defined in the Circular unless the context requires otherwise.

The Directors are pleased to announce that at the SGM held on January 9, 2008, the resolution to approve the Transaction (the "Resolution") was duly passed by the Shareholders at the SGM by way of poll.

The total number of Shares entitling the Shareholders to attend and vote for or against the Resolution at the SGM is 2,617,112,363 Shares, representing 100 % of the entire issued share capital of the Company as at the date of this announcement. None of the Shares entitled the holders to attend and vote only against the Resolution at the SGM.
