The Company announces that the Conversion Price has been adjusted from HK\$8.37 per Share to HK\$8.18 per Share as a result of the approval for the payment of the final dividend and final special dividend of an aggregate amount of HK\$0.12 per Share in respect of the financial year ended 31st December, 2005, which adjustment became effective from 25th May, 2006.
