#### INTRODUCTION

At the forthcoming AGM, resolutions will be proposed to seek the Shareholders' approval for, among other things, (i) the granting of the General Mandate and the Repurchase Mandate to the Directors; and (ii) the re-election of Directors.

The purpose of this circular is to provide you with information relating to the resolutions to be proposed at the AGM for the proposed grant of the General Mandate and the Repurchase Mandate and the proposed re-election of Directors and the notice of the AGM.

#### GENERAL MANDATE AND REPURCHASE MANDATE

At the AGM, the Directors propose to seek the approval of the Shareholders to grant to the Directors the General Mandate and the Repurchase Mandate.

#### General Mandate

At the AGM, an ordinary resolution will be proposed such that the Directors be given an unconditional general mandate (i.e. the General Mandate) to allot, issue and deal with unissued Shares or underlying shares of the Company (other than by way of rights or pursuant to a share option scheme for employees of the Company or Directors and/or any of its subsidiaries or pursuant to any scrip dividend scheme or similar arrangements providing for the allotment and issue of Shares in lieu of whole or part of the dividend on Shares in accordance with the Bye-laws) or make or grant offers, agreements, options and warrants which might require the exercise of such power, of an aggregate amount of up to 20% of the issued Shares as at the date of granting of the General Mandate.

#### Repurchase Mandate

At the AGM, an ordinary resolution will also be proposed such that the Directors be given an unconditional general mandate to repurchase Shares (i.e. the Repurchase Mandate) on the Stock Exchange of an aggregate amount of up to 10% of the issued Share as at the date of granting of the Repurchase Mandate.

Subject to the passing of the resolution for the approval of the Repurchase Mandate and on the basis that no further Shares are issued or repurchased between the Latest Practicable Date and the date of the AGM, the Company would be allowed under the Repurchase Mandate to repurchase a maximum of 217,790,000 Shares.

This Appendix serves as an explanatory statement, as required by the Listing Rules, to provide requisite information to you for your consideration of the Repurchase Mandate.

#### 1. REPURCHASE OF SECURITIES FROM CONNECTED PARTIES

The Listing Rules prohibit the Company from knowingly purchasing its securities on the Stock Exchange from a "connected person", that is, a director, chief executive or substantial shareholder of the Company or any of its subsidiaries or their respective associates (as defined in the Listing Rules) and a connected person is prohibited from knowingly selling to the Company his/her/its securities of the Company.

No connected person of the Company has notified the Company that he/she/it has a present intention to sell any Shares to the Company nor has any such connected person undertaken not to sell any of the Shares held by him/her/it to the Company in the event that the Repurchase Mandate is passed.

#### 2. SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company comprised 2,177,900,000 fully paid Shares.

Subject to the passing of the proposed resolution for the approval of the Repurchase Mandate and on the basis that no further Shares are issued or repurchased by the Company prior to the AGM, the Company will be allowed under the Repurchase Mandate to repurchase a maximum of 217,790,000 fully paid Shares, representing 10% of the issued share capital of the Company as at the date of passing of the resolution.

#### 3. REASONS FOR THE REPURCHASE

The Directors believe that the Repurchase Mandate is in the best interests of the Company and the Shareholders as a whole. He has been the Chairman of Movie Producers and Distributors Association of Hong Kong Limited since 1997, an association established in Hong Kong representing the interests of the local firm industry.

Mr. Wong also acts as directors of several subsidiaries of the Group. Other than acting as an executive Director and the directors of other companies within the Group as disclosed herein, Mr. Wong did not have any positions held with the Company and other members of the Group nor any other directorship held in the last three years in public companies the securities of which are listed on any securities market in Hong Kong or overseas.

Mr. Wong has entered into a service agreement with the Company for a term of one year commencing on 1 April 2009 and shall continue thereafter until terminated by either party giving to the other party not less than three months' prior written notice. Mr. Wong is subject to retirement by rotation and re-election at general meetings in accordance with the Bye-laws. His remuneration is fixed at HK\$49,000 per month, which commensurate with his duties and responsibilities as executive Director and the prevailing market situation. Mr. Wong is also entitled to (i) a discretionary bonus to be determined by the Board by reference to the audited consolidated net profit of the Group after taxation and minority interests but before extraordinary items (the "Net Profit") provided that the aggregate amount of discretionary bonuses payable in each financial year to all executive Directors shall not exceed 5% of the Net Profit of the relevant financial year; and (ii) a year end bonus equivalent to one month's basic remuneration upon each completed year of service.

As at the Latest Practicable Date, Mr. Wong has, in aggregate, deemed interests of 230,586,488 Shares, representing approximately 10.59% of the entire issued share capital of the Company of which (i) 212,570,000 Shares are owned by Capeland Holdings Limited, which is wholly owned by Mr. Wong; (ii) 14,257,700 Shares are personally held by Mr. Wong; (iii) 2,566,888 options granted to Mr. Wong; and (iv) 1,191,900 Shares are beneficially owned by Ms. Zee Ven Chu, Lydia, the spouse of Mr. Wong. Save as disclosed above, Mr. Wong does not have, and is not deemed to have, any other interests in shares of the Company within the meaning of Part XV of the SFO.

Save for the fact that Mr. Wong is the brother of Ms. Wong Kit Fong, the senior management of the Company as well as his relationship with Capeland Holdings Limited as disclosed above, Mr. Wong has no relationship with other Directors, senior management or substantial or controlling Shareholders of the Company.

#### (2) Mr. Hui Wai Lee Willy ("Mr. Hui")

Mr. Hui, aged 48, is an executive Director. He is currently a director of Supreme Jewellery Company. Mr. Hui has over 28 years' experience in designing and manufacturing of European-style jewelry.

Mr. Hui has entered into a service contract with the Company for an initial term of one year commencing from 6 April 2009 and shall continue thereafter until terminated by either party in writing. He is subject to retirement by rotation and/or re-election at general meetings in accordance with the Byelaws. Pursuant to his service contract, Mr. Hui is entitled to a basic remuneration of HK\$13,000 per month (including any sum receivable as director's fee or other remuneration from any member of the Group) which was determined with reference to his duties and responsibilities with the Company. He is also entitled to (i) a discretionary bonus to be determined by the Board by reference to the Net Profit provided that the aggregate amount of discretionary bonuses payable in each financial year to all executive Directors shall not exceed 5% of the Net Profit of the relevant financial year; and (ii) a year end bonus equivalent to one month's basic remuneration upon each completed year of service.

As at the Latest Practicable Date, Mr. Hui does not have, and is not deemed to have, any interests in shares of the Company within the meaning of Part XV of the SFO. Mr. Hui does not have any relationship with any Directors, senior management or substantial or controlling Shareholders of the Company. Save for being the executive Director, he did not hold any directorship in the last three years in public companies the securities of which are listed on any securities market in Hong Kong or overseas nor any position within the Group.

#### (3) Mr. Choy Sze Chung, Jojo ("Mr. Choy")

Mr. Choy, aged 50, an independent non-executive Director who is the Vice Chairman of National Resources Securities Limited. Mr. Choy has extensive experience in the securities industry and business management.

Mr. Choy has been invited to various investment seminars. He obtained his Master of Business Administration Degree from University of Wales, Newport and his Master of Business Law Degree from Monash University, Australia. Mr. Choy is also the Vice Chairman of the Institute of Securities Dealers Limited, an independent non-executive director of Chengdu PUTIAN Telecommunications Cable Company Limited (Stock Code: 1202), an independent non-executive director of Zhaojin Mining Industry Company Limited (Stock Code: 1818), an independent non-executive director of Sparkle Roll Group Limited (Stock Code: 970), a Committee Member of Society of Registered Financial Planner Ltd., a Fellow Member of Institute of Financial Accountants, a Fellow Member of the Institute of Compliance Officer, a Member of CPPCC Shantou, a Honorary President of Shantou Overseas Friendship Association, a Honorary President of Shantou Overseas Exchanges Association, a Honorary Principal of the school of Chen Po Sum and a Council Member of Rotary Club Kowloon West. Save as disclosed above, Mr. Choy did not hold any directorship in the last three years in public companies the securities of which are listed on any securities market in Hong Kong or overseas nor any position within the Group.

### DETAILS OF DIRECTORS PROPOSED TO BE RE-ELECTED AT THE AGM

Pursuant to his appointment letter, Mr. Choy is appointed for a term of one year and shall continue thereafter until terminated by either party in writing. Mr. Choy is subject to retirement by rotation and re-election at general meetings in accordance with the Bye-laws. Mr. Choy's remuneration is fixed at HK\$120,000 per annum, which commensurate with his duties and responsibilities as the independent non-executive Director and the prevailing market situation. Mr. Choy is not entitled to any bonus payment to the Company.

Save for the fact that Mr. Choy is the cousin of Mr. Chan Tung Tak Alain, an independent non-executive Director, Mr. Choy has no relationship with other Directors, senior management or substantial or controlling Shareholders of the Company nor any interest in the shares of the Company within the meaning of Part XV of the SFO.
