CHANGE OF COMPANY NAME AND CHANGE OF STOCK SHORT NAME

The Board is pleased to announce that with effect from 3 April 2008, the English name of the Company has been changed from “IIN International Limited” to “China Ground Source Energy Limited 中國地能有限公司”.

The English stock short name of the Company for trading in Shares on the Stock Exchange will be changed from “IIN INT’L” to “C G SOURCE ENGY” and the Chinese stock short name of the Company for trading in Shares on the Stock Exchange will be changed from “國訊國際” to “中國地能” with effect from 18 June 2008.

Reference is made to the circular (“**Circular**”) of the Company dated 6 March 2008. Unless the context otherwise requires, capitalized terms defined in the Circular shall have the same meanings when used in this announcement.

The Board is pleased to announce that the special resolution regarding the change of the English name of the Company from “IIN International Limited” to “China Ground Source Energy Limited 中國地能有限公司” was approved by the Shareholders at the EGM held on 31 March 2008. The certificate of incorporation on change of name was issued by the Registry of Companies in the Cayman Islands on 3 April 2008 and the certificate of registration of change of corporate name of non-Hong Kong company was issued by the Registrar of Companies in Hong Kong on 3 June 2008. The change of name of the Company has become effective from 3 April 2008.

The English stock short name of the Company for trading in Shares on the Stock Exchange will be changed from “IIN INT’L” to “C G SOURCE ENGY” and the Chinese stock short name of the Company for trading in Shares on the Stock Exchange will be changed from “國訊國際” to “中國地能” with effect from 18 June 2008.

The change of the name of the Company will not affect any of the rights of the existing Shareholders. All existing share certificates in issue bearing the former name of the Company will continue to be evidence of legal titles to the Shares and will remain valid for trading, settlement, registration and delivery purposes. There will not be any arrangement for free exchange of existing share certificates of the Company for new Share certificates under the new name. However, new share certificates of the Company will be issued under the new name of the Company with effect from 18 June 2008.
