**POLL RESULTS OF THE AGM HELD ON 23 JUNE 2016**

The Board is pleased to announce that the AGM was held on 23 June 2016 during which the resolutions stated in the notice convening the AGM were duly passed without modification by Shareholders attending and voting at the AGM either in person or by proxy or by their duly authorised representatives by way of poll. Tricor Tengis Limited, the Company’s Hong Kong branch registrars, acted as the scrutineer for the purpose of vote-taking at the AGM.

As at the date of the AGM, there were 5,251,084,922 Shares in issue, which was the total number of Shares entitling the holders to attend and vote for or against the resolutions proposed at the AGM. There were no shares entitling the holder to attend and vote only against the resolutions at the AGM.
