This voluntary announcement is made by China Smartpay Group Holdings Limited (the “**Company**”). The board of directors of the Company (the “**Board**”) was notified by Mr. Zhang Huaqiao (“**Mr. Zhang**”), the Chairman and an executive director of the Company, that on 8 January 2016, Mr. Zhang acquired 150,000 shares of the Company on the secondary market at a consideration of an average price of HK\$1.75 per share (the “**Acquisition**”). Details of the change in the shareholding interests of the Company held by Mr. Zhang as a result of the Acquisition are set out as follows:–
