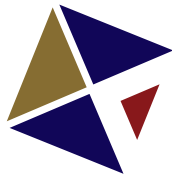

RESULTS OF SPECIAL GENERAL MEETING HELD ON 12 MAY 2010

The Board is pleased to announce that the ordinary resolution as set out in the notice of the SGM contained in the Circular was duly approved by the Independent Shareholders by way of poll at the SGM held on 12 May 2010.

Reference is made to the circular incorporating a notice of special general meeting of China Properties Investment Holdings Limited (the “**Company**”) dated 26 April 2010 (the “**Circular**”), in relation to the Refreshment of General Mandate. Unless otherwise defined, terms used herein shall have the same meaning as defined in the Circular.

POLL RESULTS OF SGM

The SGM was held on 12 May 2010 to consider the ordinary resolution to ratify and approve the Refreshment of General Mandate, which was subject to the approval by the Independent Shareholders at the SGM. Details of the ordinary resolution were set out in the notice of the SGM.

The Board is pleased to announce that the ordinary resolution as set out in the notice of the SGM was duly approved by the Independent Shareholders by way of poll at the SGM.

The Company's Hong Kong branch share registrars and transfer office, Tricor Secretaries Limited, was appointed as the scrutineer at the SGM for the purpose of vote-taking. The poll result of the resolution is as follows:

As at the date of the SGM, the total number of issued shares of the Company was 5,052,909,761 Shares. As stated in the Circular, Ms. Yu Wai Fong, the chairman and executive director of the Company and who was interested in 512,630,358 Shares, representing approximately 10.15% of the total issued share capital of the Company as at the date of the SGM, was required to abstain from voting on the aforesaid ordinary resolution.

In addition, the total number of Shares held by the Independent Shareholders who were entitled to attend and vote for or against the ordinary resolution was 4,540,279,403 Shares.
