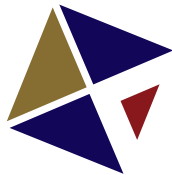

PLACING OF NEW SHARES

Placing Agent

Cheong Lee Securities Limited

On 6 September 2010 after trading hours, the Company entered into the Placing Agreement with the Placing Agent pursuant to which the Placing Agent has agreed to place, on a best effort basis, to not less than six independent Placees for up to 360,000,000 new Shares at a price of HK\$0.056 per Placing Share, for and on behalf of the Company.

The Placing is conditional upon the Listing Committee of the Stock Exchange granting the listing of and permission to deal in the Placing Shares. If such condition is not fulfilled, the Placing will not proceed.

The maximum number of 360,000,000 Placing Shares represents approximately 19.7% of the entire issued share capital of the Company of 1,823,789,499 Shares as at the date of this announcement and approximately 16.5% of the Company's entire issued share capital as enlarged by the Placing. The net proceeds from the Placing of approximately HK\$19.4 million (assuming the Placing Shares are fully placed and after all relevant expenses) will be used for development of the mine as set out in the Company's announcements dated 27 August 2010 and/or general working capital of the Group.

THE PLACING AGREEMENT

Date: 6 September 2010

Placing Agent: Cheong Lee Securities Limited. To the best of the Company's knowledge, information and belief after making reasonable enquiries, the Placing Agent and its ultimate beneficial owners are Independent Third Parties.

Placees: The Placing Shares will be placed to not less than six Placees (who will be independent individual, corporate and/or institutional investors) and their ultimate beneficial owners will be Independent Third Parties. It is expected that no Placee will become a substantial Shareholder (as such term is defined in the Listing Rules) immediately following completion of the Placing.

Number of Placing Shares: Up to 360,000,000 new Shares, to be placed by the Placing Agent on a best effort basis. Assuming the Placing Shares are fully placed, the Placing Shares represents approximately 19.7% of the entire issued share capital of the Company of 1,823,789,499 Shares as at the date of this announcement and approximately 16.5% of the Company's entire issued share capital as enlarged by the Placing. The nominal value of the Placing Shares is HK\$18,000,000.00.

Placing Price: HK\$0.056 per Placing Share. The Placing Price was agreed after arm's length negotiations between the Company and the Placing Agent, with reference to, among other things, the recent trading price of the Shares on the Stock Exchange. The Placing Price represents:

- (a) a discount of approximately 9.68% to the closing price of HK\$0.062 per Share as quoted on the Stock Exchange on 6 September 2010, being the date of the Placing Agreement;
- (b) a discount of approximately 19.54% to the average closing price of approximately HK\$0.0696 per Share as quoted on the Stock Exchange for the last 5 full trading days of the Shares immediately before the date of the Placing Agreement.

The Company will bear the costs and expenses in connection with the Placing and the net proceeds from the Placing is estimated to be approximately HK\$19.4 million (assuming the Placing Shares are fully placed). As a result, the net price per Placing Share will be approximately HK\$0.054 .

Placing Commission: The Placing Agent will receive a placing commission of 3% on the gross proceeds of the Placing.

General Mandate:	The Placing Shares will be issued pursuant to the general mandate to allot, issue and deal with Shares granted to the Directors by resolution of the Shareholders passed at the Company's annual general meeting held on 31 August 2010 up to 364,757,899 Shares. As at the date of this Announcement, no Share has been issued pursuant to the general mandate.
Ranking of Placing Shares:	The Placing Shares, when issued and fully paid, will rank pari passu among themselves and with Shares in issue at the time of issue and allotment of the Placing Shares.

Completion of the Placing:	Subject to the satisfaction of all the conditions set out above, the Placing is expected to be completed on or before 27 September 2010 or such later time and/or such other date as the Placing Agent and the Company may agree.

- (e) the imposition of any moratorium, suspension or material restriction on trading in securities generally on the Stock Exchange occurring due to exceptional financial circumstances or otherwise; or
- (f) a change or development involving a prospective change in taxation in Hong Kong, Bermuda or the People's Republic of China or the implementation of exchange controls which shall or might materially and adversely affect the Group or its present or prospective shareholders in their capacity as such; or
- (g) any change or deterioration in the conditions of local, national or international securities markets.

Note: Gold Trinity International Limited is wholly-owned by Mr. Han Wei (韓衛), a director of a wholly-owned subsidiary of the Company. As at the date of this announcement, Gold Trinity International Limited is the holder of the convertible bonds issued by the Company on 27 July 2009 in an outstanding principal amount of HK\$27 million at the conversion price of HK\$0.073 per conversion share.

REASONS FOR AND BENEFITS OF THE PLACING AND USE OF THE PROCEEDS

The Group is principally engaged in (i) the properties investment business, comprising the rental of investment properties and the provision of the property management services; and (ii) the exploitation of copper and molybdenum in a mine located in Inner Mongolia, the PRC.

In view of the current market conditions, the Directors consider that the Placing represent a good opportunity to broaden the shareholders base and capital base of the Company and to raise capital for the Company for its future business developments. The Directors consider the terms of the Placing Agreement to be fair and reasonable and in the interest of the Group and the Shareholders as a whole.

Subject to the Placing being completed, the Company will bear all costs and expenses of approximately HK\$0.76 million in connection with the Placing. The net proceeds of approximately HK\$19.4 million from the Placing will be used for development of the mine as set out in the Company's announcements dated 27 August 2010 and/or general working capital of the Group.
