EXTENSION OF MEMORANDUM OF UNDERSTANDING

Unless otherwise specified, terms used herein shall have the same meanings as defined in the Announcements.

The Board wishes to announce that on 16 October 2013, the Company entered into a letter of confirmation with the BVI Cos and the Guarantor whereby, inter alia, the term of the MOU as amended by the SMOU and the 2nd SMOU and the letters of confirmation dated 20 October 2010, 20 December 2010, 24 March 2011, 21 June 2011, 9 September 2011, 20 September 2011, 21 December 2011, 20 March 2012, 20 June 2012, 2 November 2012 and 24 December 2012 respectively was further extended for three months to 20 December 2013. The date of the exclusivity period has also been extended to 20 December 2013.

The Board wishes to emphasize that the Possible Acquisition is subject to, among other things, the signing of a formal agreement for the sale and purchase of the Target Company, the terms and conditions of which are yet to be agreed. As the Possible Acquisition may or may not materialise, Shareholders and potential investors of the Company should exercise caution when
