VOLUNTARY ANNOUNCEMENT

This is a voluntary announcement made by the Company.

The board (the "Board") of directors (the "Directors") of Oriental City Group Holdings Limited (the "Company", and together with its subsidiaries, the "Group") have noted and have been closely monitoring the recent political unrest and violence that has occurred in Thailand.

The Board would like to inform its shareholders and potential investors that the recent political unrest occurred primarily in the urban districts of Bangkok, Thailand, where the Group's Thai business is headquartered, and the Directors note that the monthly transaction volume processed by Oriental City Group (Thailand) Co., Ltd (the "OCGT"), a subsidiary of the Company, has been very volatile. This reflects a reduction in the number of PRC tour groups coming to Thailand following a warning issued in mid-April by the China National Tourism Administration notifying them to temporarily suspend visits to Thailand. The transaction volume handled by OCGT for April 2010 was approximately Baht 124 million (April 2009: Baht 273 million) while the transaction volume for the first half of May 2010 was approximately Baht 46 million (first half of May 2009: Baht 30 million). Meanwhile, the Directors can confirm that as at the date of this announcement the members of staff of OCGT are safe and unharmed and the Company's property and transaction data storage facilities and the POS terminals operated by the Company's merchants have not been damaged or compromised.

However, as the office of the auditor of OCGT is located in the area of Bangkok affected by the disturbances and the Directors understand that the relevant staffs are currently forbidden to enter the office building, there is a risk that if the Bangkok security situation deteriorates further this may make it more difficult for the Company to report its financial results for year ended 31 March 2010 on time. If such a scenario seems probable, the Company will issue another announcement.

The Board would also like to inform its shareholders and potential investors that, as a result of the on-going political unrest in Thailand, the Group is also considering reallocating a portion of the use of proceeds raised from the placing of Company's shares which were listed on the Growth Enterprise Market of The Stock Exchange of Hong Kong Limited on 28 August 2009 in order to diversify the business risk of the Company. If such decision is made, then the Company will issue an appropriate announcement.

Shareholders and potential investors in the Company are advised to exercise caution when dealing in the shares of the Company.
