To be valid, this form of proxy together with any power of attorney or other authority (if any) under which it is signed or a notarially certified copy of such power or authority must be deposited at the branch share registrar and transfer office of the Company in Hong Kong, Trior Secretaries Limited, at 26/F Tesbury Centre, 28 Queen's Road East, Hong Kong not later than 48 hours before the time of the annual general meeting or any adjournment thereof. i Any alteration made to this form of proxy should be initialled by the person who signs the form.
