The Board is pleased to announce the unaudited consolidated turnover of the Group for the three months ended 31 March 2014.

The board of directors (the “Board”) of Zhongyu Gas Holdings Limited (the “Company”) is pleased to announce the unaudited consolidated turnover of the Company and its subsidiaries (together, the “Group”) for the three months ended 31 March 2014.

For the three months ended 31 March 2014, the Group’s unaudited consolidated turnover amounted to approximately HK\$783,508,000 compared to approximately HK\$708,920,000 for the corresponding period in 2013, representing an increase of approximately 10.5%.

Turnover represents the net amounts received and receivable for goods sold and services rendered by the Group to outside customers, net of discounts and related taxes. An analysis of the Group’s unaudited consolidated turnover for the three months ended 31 March 2014, together with the comparative figures for the corresponding period in 2013 are as follows:
