CHARACTERISTICS OF THE GROWTH ENTERPRISE MARKET (“GEM”) OF THE STOCK EXCHANGE OF HONG KONG LIMITED (THE “STOCK EXCHANGE”)

GEM has been established as a market designed to accommodate companies to which a high investment risk may be attached. In particular, companies may list on GEM with neither a track record of profitability nor any obligation to forecast future profitability. MANAGEMENT DISCUSSION AND ANALYSIS

Financial Review

For the nine months ended 30 September 2008, the Group recorded a turnover of approximately HK\$246.27 million, representing an increase of approximately 3,107% as compared to approximately HK\$7.68 million for the corresponding period in 2007. Profit attributable to equity holders of the Company for the nine months ended 30 September 2008 was approximately HK\$26.61 million as compared to loss attributable to equity holders of the Company of approximately HK\$6.44 million for the corresponding period in 2007.

Business Review

The Group mainly focused on the production and sale of expandable polystyrene (“EPS”) and paper honeycomb packaging products. The Group is in a leading position in the EPS cushion packaging industry for electrical appliances in the PRC. The Group provides excellent integrated packaging solutions to its customers that including design, R&D, testing and manufacturing of packaging products. The Group has established clientele comprising certain renowned electrical appliance manufacturers in the PRC.

During the period under review, the substantial increase in Group’s turnover and profit attributable to equity holders as compared to the corresponding period was due to the Group acquired two EPS packaging businesses in January 2008. The Acquired packaging businesses provide a good mix of cushion packaging solutions. They comprise of companies with sound track record of manufacturing and sales of EPS packaging materials, as well as companies providing design and cast production services. The Acquired EPS packaging businesses have contributed substantial profit to the Group for the nine months ended 30 September 2008.

Business Outlook

As the economic environment has been deteriorating, the Group will continue enhance its product design and production expertise, reinforce people training and strengthen its operational efficiency so as to maintain its competitive edge.

Notes:

1. Basis of preparation and principal accounting policies

The unaudited condensed consolidated results for the period ended 30 September 2008 (the “Period”) have been prepared in accordance with Hong Kong Financial Reporting Standards (“HKFRSs”) (which also include Hong Kong Accounting Standards (“HKASs”) and Interpretations), issued by the Hong Kong Institute of Certified Public Accountants (“HKICPA”), accounting principles generally accepted in Hong Kong and the disclosure requirements of Chapter 18 of the Rules Governing the Listing of Securities on the Growth Enterprise Market of the Stock Exchange of Hong Kong Limited (the “Stock Exchange”) (the “GEM Listing Rules”).

The Group has adopted the following standards that have been issued and effective for the periods beginning on or before 1 January 2008. The adoption of such standards did not have material effect on these financial statements.

3. Segment information

Most of the Group's assets, liabilities and capital expenditure are located or utilised in the PRC, Accordingly, no segment information is presented.

4. Income tax

No provision for Hong Kong profits tax has been provided as the Group has no assessable profit in Hong Kong. The provision for PRC income tax is calculated based on the statutory income tax rate according to the relevant laws and regulations in the PRC. (2007: Nil)

5. Dividend

For the nine months ended 30 September 2008, the Board does not recommend the payment of an interim dividend (2007: Nil).

The audit committee currently comprises three independent non-executive directors, namely Mr. Ho Ka Wing, Mr. Cheng Yun Ming, Matthew and Mr. Sin Ka Man.

The Group's unaudited condensed consolidated quarterly results for the nine months ended 30 September 2008 have been reviewed by the audit committee, which was of the opinion that the preparation of such results complied with the applicable accounting standards and requirements and that adequate disclosures have been made.
